

# Official Contest Rules and Regulations Victoria Day 2019 Contest

The Brim La-Z-Boy 2019 Contest ("Contest") is sponsored and administered by Brim Financial Inc. ("Brim"). The Contest will be ongoing from 12:00 p.m., May 15, 2019 until 12:00 p.m., May 21, 2019 Eastern Time (the "Contest Period").

## 1. Eligibility

The Contest is open to all Canadian residents, except those resident in the province of Quebec, who have reached the legal age of majority in their province or territory prior to the Contest Period ("Eligible Participant"). Employees, representatives or agents of Brim and its subsidiaries and affiliates, media partners, advertising and promotional agencies, and members of the immediate family (parents, children, siblings and spouse, regardless of where they are domiciled) of any of the aforementioned and persons with whom any of the aforementioned are domiciled are not eligible to enter the Contest.

## How to participate in the Contest

No purchase necessary. To enter the Contest, an Eligible Participant must during the Contest Period, "like" Brim's "La-Z-Boy Contest" post on Instagram, and follow each of @brimfinancial, and @lazboygta. In addition, the Eligible Participant must tag three friends. One entry only per person.

Alternatively, the Contest may be entered by writing a 400-word statement on the entrant's favourite Brim card feature and sent to Brim at social@brimfinancial.com. Each original, non-replicated statement will entitle the entrant to one (1) contest entry. Entries must be received prior to the end of the Contest Period.

### 2. Prizes

There are two (2) prizes (each a "Prize") to be won, consisting of C\$500 gift card which may be redeemed at any La-Z-Boy Canada location for La-Z-Boy merchandise. Only one (1) Prize can be won per person.

The approximate retail value of each Prize is CDN\$500.

Prize must be accepted as awarded and may not be sold, transferred or converted to cash and will not be refunded if unused. No substitutions, changes or extensions are permitted. Brim reserves the right at its sole discretion to substitute the Prize for one of equal or greater value or to allow a Prize transfer.

## **Winner Selection**

At 2 p.m. EDT in Toronto, Canada on Tuesday, May 21, 2019 (the "**Draw Time**"), three staff members or representatives of Brim (collectively, the "**Judges**") will tally all eligible Contest Entries identified or received during the Contest Period and electronically randomly choose three (3) potential winners from all eligible entries received or identified prior to the end of the Conest Period .

Odds of winning depend on the number of eligible Contest Entries received or identified prior to the end of the Contest Period .

## 3. Claiming of Prizes

In order to be declared a winner and be able to claim a Prize, the Eligible Participants selected by the Judges will be announced on Instagram at 2:30 p.m. May 21, 2019 and each selected Eligible Participant will be contacted by email by Brim, or one of its agents or representatives, shortly following the draw and must confirm acceptance as a selected Eligible Participant within 48 hours (forty-eight) of the send time of the e-mail. If the Eligible Participant cannot be contacted or does not respond within this time period any chance to win a Prize will be forfeited. Before

being declared a winner, the selected Eligible Participant will be required to answer correctly, unaided, a timelimited mathematical skill-testing question and sign a release and waiver form confirming, without limitation, that:

- He/she complies with the eligibility requirements;
- The contents of his/her Contest Entry, as appropriate, is original and does not infringe any third-party rights (e.g. image, photograph, etc., that are posted);
- he/she has read the Contest rules and regulations and complies completely;
- he/she accepts the Prize as awarded;
- he/she acknowledges Brim's right to publish his/her picture, name and city of residence without compensation other than the Prize offered;
- he/she correctly answers unaided a time-limited mathematical skill-testing question; and

Brim will not be held responsible for any technological malfunctions, telephone or internet interruptions and/or any late/incomplete/erroneously completed Prize claims or release and waiver forms. Furthermore, each Eligible Participant is responsible for ensuring that content posted or displayed as part of his/her Contest Entry is original and does not infringe, misappropriate or violate a third party's patent, copyright, trademark, trade secret, moral rights or other intellectual property rights, or rights of publicity or privacy and applicable law.

The contents of all entries submitted become property of Brim. Eligible Participants further agree that all entries submitted and their content become the property of Brim and will not be returned.

Eligible Participants agree to be bound by all decisions of Brim regarding the Contest which shall be final and binding in all respects.

Eligible Participants agree that Brim is not liable for any incorrect or inaccurate transcription of entry information or for any error or malfunction of any kind in connection with the Contest.
