

INITIAL DISCLOSURE STATEMENT

The following forms part of the Brim Financial Inc. Mastercard Cardmember Agreement (the “**Agreement**”) and provides a summary of important information about your Card and Account. The interest rates/credit rates and fees listed below apply to all credit cards issued by Brim Financial Inc., are current and effective as of October 1, 2017 unless otherwise noted and are subject to change in accordance with your Agreement.

Annual Interest Rates (in Quebec, the Credit Rates)	<p>18.99% for Purchases</p> <p>18.99% for Balance Transfers</p> <p>21.50% for Cash Advances (other than Balance Transfers)</p> <p>18.99% (or the lower applicable promotional rate, if any) for Installment Pay Plans</p>
Interest-free Grace Period	<p>Your Payment Due Date is at least 21 days after the last day of the statement period shown on your monthly statement. If your Agreement is governed by the laws of the Province of Quebec, the interest-free grace period is at least 21 days from the date the monthly statement is mailed to you or its availability to you in electronic form (if you have agreed to receive your monthly statement in electronic form). This period of time is called the interest-free grace period. This means that interest will not be charged on new Purchases or on any other amount included in your Balance (other than Cash Advances), if we receive payment in full of the Balance on your current monthly statement by the Payment Due Date.</p> <p>There is no interest-free grace period for Cash Advances (which includes Balance Transfers, Convenience Cheques and Cash-Like Transactions).</p>
Determination of Interest	<p>If interest is charged on Transactions or on any other charges that make up your Balance, it is calculated using the “average daily balance method”. The “average daily balance method” results in the monthly compounding of interest. Please see the “Interest and Grace Periods” section of your Agreement for more details.</p> <p>For interest charged on Purchases that are subject to Installment Pay Plans, see “Installment Pay” section of your Agreement for more details.</p>
Total Minimum Payment	<p>The Total Minimum Payment shown on each monthly statement will be the sum of: (i) \$10.00, (ii) the fees and interest shown on your current monthly statement, (iii) the current installment(s) under any Installment Pay Plan shown on your current monthly statement (if any), (iv) any amount by which your Balance exceeds your Credit Limit, and (v) any previously unpaid Total Minimum Payments. However, if your monthly statement Balance is less than \$10.00, your Total Minimum Payment will be the full Balance. The Total Minimum Payment must be paid by the Payment Due Date to avoid being in default of your Agreement.</p>
Foreign Currency Conversion	<p>We do not charge a fee for foreign currency conversions. If you use the Account to make Purchases or obtain Cash Advances in a foreign currency, the foreign currency will be converted to Canadian dollars before it is recorded in the Account. For foreign currency transactions, the rate will be the exchange rate set by Mastercard and applied at the time of the conversion, and is generally reset daily. The rate that is used will be the rate on the date that a Transaction is recorded in the Account and may be different from the rate in effect on the date of the Transaction. In the case of a return of an item purchased in a foreign currency, the dollar amount credited to the Account may be less than the Canadian dollar amount that was originally debited to the Account.</p>

Other Fees	<p>To be charged on the day the transaction or activity occurs, unless otherwise specified:</p> <p><i>NSF Fee/Dishonored Payment: \$25.00</i> each (except for Cardmembers resident in the Province of Prince Edward Island).</p> <p><i>Cash Advance Fee (in Canada): \$3.50</i></p> <p><i>Cash Advance Fee (outside of Canada): \$5.00</i></p> <p><i>Duplicate Statement Fee: \$5</i> for each additional paper copy of your paper monthly statement.</p> <p><i>Copy of Sales Draft: \$5</i> for each copy of a sales draft (except for Cardmembers resident in the Province of Quebec).</p> <p><i>Fast Card Fee</i> for courier delivery or international delivery of replacement Cards: \$25</p>

Monthly Statement Frequency: Unless otherwise required by law, we will provide the Primary Cardmember with a monthly statement if there has been any activity on the Account during the last billing period or if there is any outstanding Balance owing or a credit balance. Except in the Province of Quebec or unless otherwise required by law, we may not provide the Primary Cardmember with a monthly statement after: (i) the Primary Cardmember has been notified that their privileges to obtain advances under your Agreement have been suspended or cancelled due to an Event of Default; and (ii) we have demanded full repayment of the outstanding Balance.

Prepayment: You are entitled to pay the full outstanding amount on your Account, including interest accrued to the date of payment, at any time without any prepayment fee, charge or penalty.

Legal Expenses: Except in the Province of Quebec, to the extent permitted by applicable law, in the event of any default under your Agreement, you will be responsible for all reasonable charges incurred by us or our agents for legal costs retained to collect or attempt to collect payment under your Agreement.

Lost or Stolen Cards or Unauthorized Use of Your Account: If your Card is loss or stolen or there are possible unauthorized Transactions or use of your Card or Account, you must immediately call us toll free at: **1-866-305-BRIM (2746)** (or collect at **1-647-251-BRIM (2746)** if you are outside Canada and the U.S.). You will not be liable for any unauthorized Transactions or use that occurs after you notify us that your Card has been lost, stolen or used in an unauthorized manner. Your liability for any unauthorized Transactions made on your Account prior to you notifying us that your Card has been lost or stolen will be a maximum of **\$50**. If you request delivery by courier service or international delivery of a replacement card, the Fast Card Fee as set out above will apply.

Balance Transfers: Balance Transfers are Cash Advances and interest is charged from the date the transfer occurs. Continue making your minimum payments on accounts from which you are transferring until the balance transfer amounts are credited to those accounts in order to avoid late charges and penalties. If the total amount to be transferred is more than your available Credit Limit, we may send your creditors either full or partial payment up to the amount of your available Credit Limit. We reserve the right to limit the number and dollar value of balance transfers and to decline them for any reason. Balances from cards and accounts of Brim Financial Inc. or its affiliates cards are not eligible to be transferred.

Examples of Monthly Credit Charges: Examples of monthly credit charges at the applicable interest rate (in Quebec, the credit rate) (assuming a balance owing during a **30**-day month covered by a monthly statement and no other fees, additional payments or other charges. All amounts rounded to the nearest cent):
